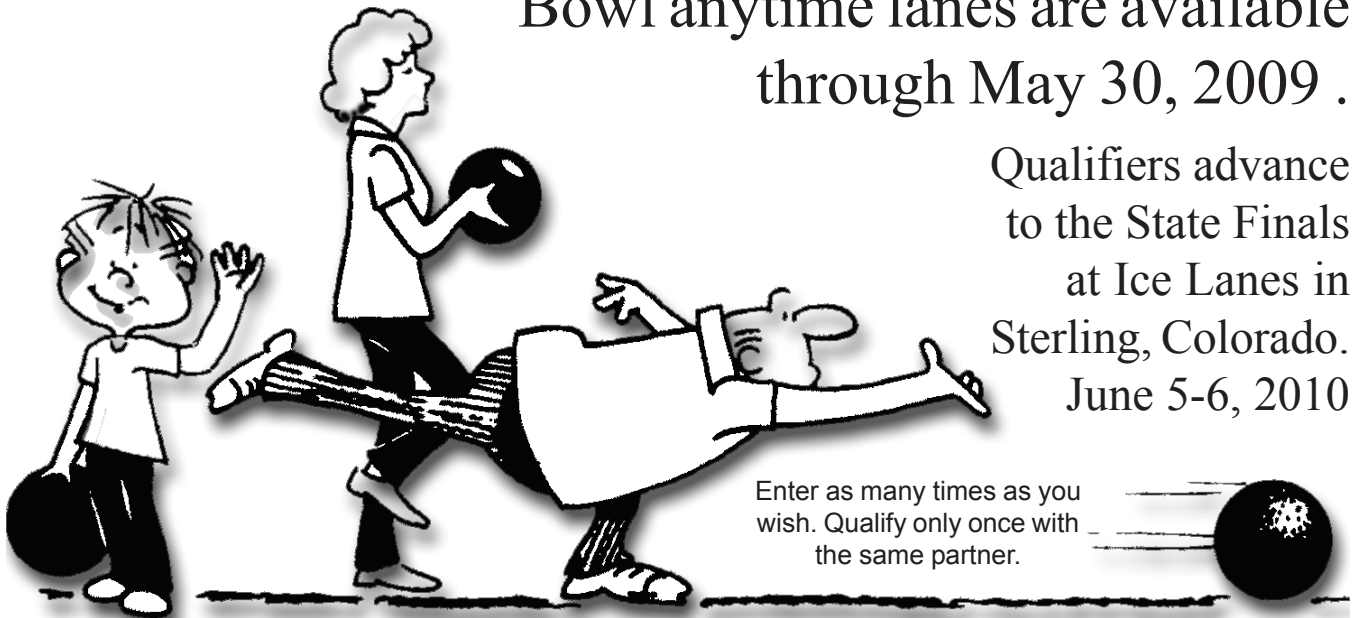

## Four Divisions:

Adult/Youth (age 12 and younger) \* Adult/Teen (age 13-18)

### THERE ARE ONLY TWO WAYS TO ADVANCE TO THE STATE FINALS:

- 1. In-House Qualifying (\$27.00 per team):** One team from every TWO entries (in each division) advances. No additional fees at the State level.
- 2. Direct Entry (\$35.00 per team):** Fill out the entry form, bowl and pay for three games, get a printout of your scores, get an average verification and pay the \$35.00 State entry fee. Team that bowl the In-House qualifier but fail to advance, may still do a direct entry into the State Finals.

**Handicap 100% from 440**

**Entry fee: \$27 per team**

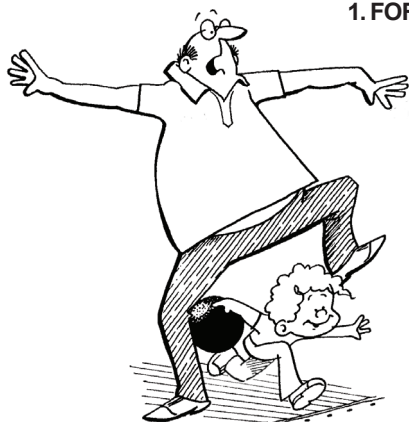

# Qubica International Family Tournament In-House Qualifying Rules & Format



## 1. FORMAT:

- A. This tournament shall be conducted in four divisions: PARENT/YOUTH - for youth ages 12 and younger; PARENT/TEEN - for youth ages 13 through 18; ADULT/YOUTH - for youth ages 12 and younger; ADULT/TEEN - for youth ages 13 through 18.
- B. The youth bowler's age as of AUGUST 1, 2009, will determine which division he/she will enter.
- C. Bowl three games on a pair of lanes.
- D. Re-entry at the center qualifying level is permitted.
- E. One for every TWO teams entered in each division at the center-level qualifying will advance to the State Finals. There will be no additional fees required at the State Finals.
- F. Eligibility - youth bowling with their parents, grandparents, great-grandparents, step-parents or legal guardians must compete in the Parent/Youth or Parent/Teen division. Youth bowling with adults other than those mentioned above must compete in the Adult/Youth or Adult/Teen divisions.

2. MULTIPLE PARTICIPATION: Adults and youth bowlers may bowl as many times as they wish BUT MAY COMPETE IN THE STATE FINALS ONLY ONCE WITH THE SAME PARTNER.

3. DATES: In-center qualifying at Bowl-ero Lanes will be conducted through May 30, 2010. State Finals will be held at Ice Lanes June 5-6, 2010. International Finals in Euless, TX, July 29 - 31, 2010.

4. IN-HOUSE QUALIFYING AVERAGES: Adult bowlers will use the higher of: 1.) the highest verifiable current league average from the 2009-10 season as of April 1, 2010; or their book average from the 2008-2009 season; or 2007-2008 season (21 games or more) or 2.) if adult has none of the above, he or she must bowl scratch (220). YOUTH BOWLERS will use the higher of: 1.) the highest verifiable current league average from the 2009-2010 season (minimum 12 games) as of April 1, 2010; or 2008-2009 book average (minimum 21 games), or 2007-2008 season (21 games or more) or 2.) if youth bowler has none of the above, he or she must bowl scratch (220). Re-rate rules will apply
